

Two-factor Authentication for login to Internet trading account

In line with the guideline by SFC and for the purpose of reduce and mitigate hacking risks associated with internet trading, Two-factor Authentication for login to your internet trading account will take effect not later than 27 April 2018. Customer is required to download designated applications via electronic mobile device to obtain a one-time password for internet trading. Details as follow:

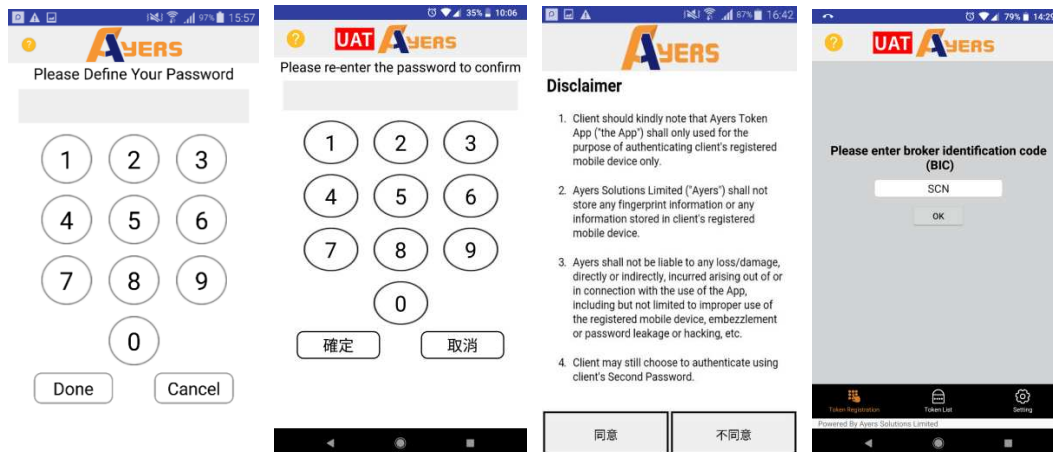
1) Download Ayers Token from App Store or Play Store



2) Install Software Token Application

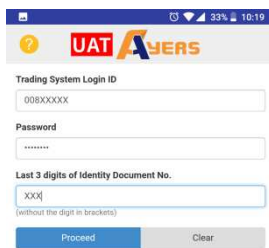
Please follow the below instructions to complete the installation procedure

3) Registration

Press “Token Registration” and follow the instructions to complete the registration process

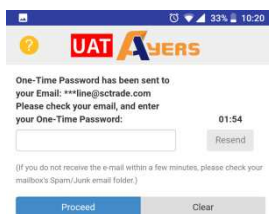
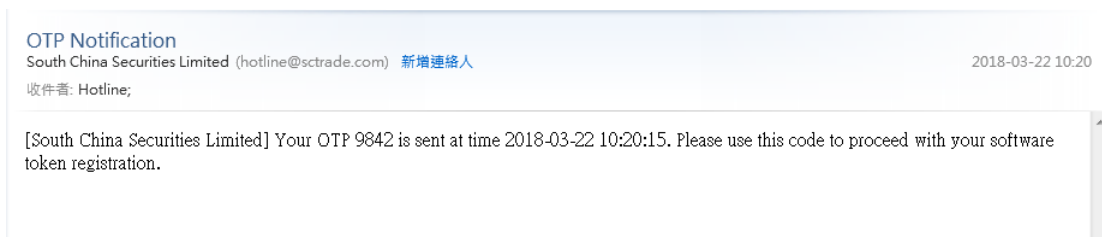

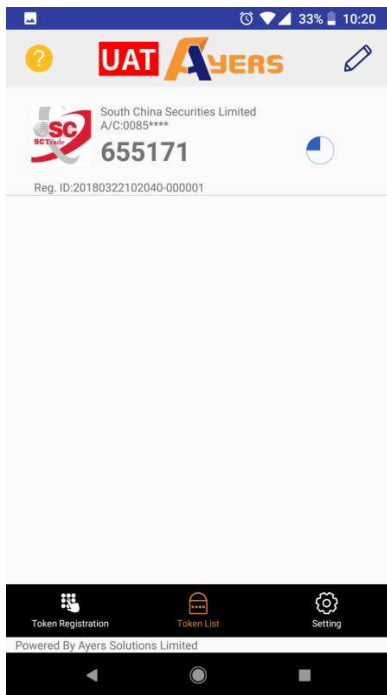

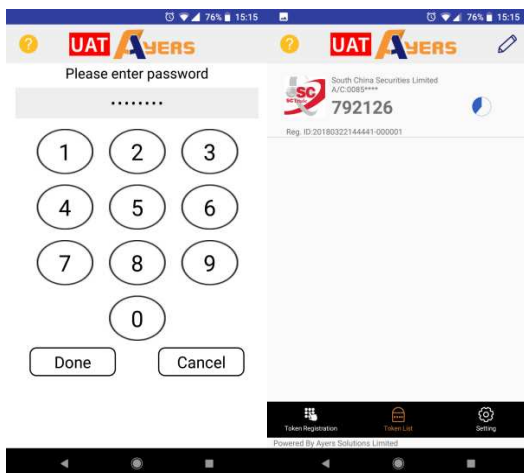
4) Registration is completed

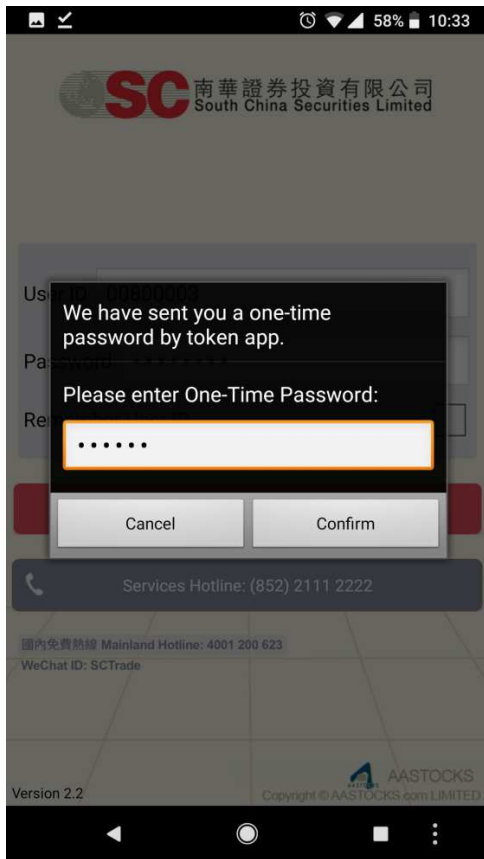
